



CLGE WORKING PLAN – ELECTION PERIOD 2003-2005

DRAFT 01 (Version by 22 March 2004)

General remarks

This working plan is based on long-term discussions in CLGE resulting in the new statutes adopted in October 2003 by the General Assembly (GA) in London.

Amongst the papers brought forward to the General Assemblies in the period 1998-2003 to assist this process of changing was:

- Draft discussion document on strategy from SEP 2001
- CLGE ROLE paper from NOV 2001
- CLGE strategy for the future from NOV 2002
- CLGE Statutes as of OCT 2003

These papers are useful in implementing the visions of CLGE.

It is of vital importance to our organisation that we - inside the frame of our limited means - do serve our members on important issues and do present our results and statements not only to the members but also to the public and to the decisionmakers.

As summed up in the last of the above mentioned papers:

CLGE intends to implement this strategy to develop the surveying profession in Europe by hosting a range of discussion papers, workshops, seminars and research grants to supply the information necessary to give us the knowledge to make good policy decisions and to take charge of our own destinies.

Main areas for the working plan are:

Professional Education

Covering issues of academic qualifications, professional qualifications & licensing procedures, professional competence, mutual recognition and Continuous Professional Development and the impact of the Bologna Model.

Professional Practice

Including issues of the private surveying sector, public surveying sector, Public-Private Relationship, Public-Private Partnership

EU Relations

Focussing on participation in EC activities related to the profession and promoting the profession in the EU and supporting accession countries over EU funding for participation and translations, advising on national surveying laws, supporting the development of national associations.

Continuous working plan issues

On every General Assembly

A specific topic is brought to discussion on a half-day session. The topic can be based on questions of special interest to the hosting country or can be put forward by the Executive

Board. It shall be announced well in advance of the next General Assembly. The topic must be introduced on the basis of papers - preferably send out in advance - giving the members the necessary possibility for preparation. A list of topics with priorities will have to be prepared. Results of these sessions in short statements can be sent out to the public and posted on the CLGE website.

Depending on the matters that the hosting country wants to bring to the General Assembly in their part of the General Assembly coordination can be established between the national part and the above-mentioned part of the General Assembly.

In every year

A one-day meeting is to be arranged on topics of importance to our members. The topic can be put forward by a member country but is normally to represent general important topics inside the frame of CLGE.

The meeting shall be held on basis of prepared papers and will normally contain 2-4 papers. The meeting shall contain a discussion forum and shall be reported to the members and to international magazines and on the CLGE website.

The meeting can be arranged in cooperation with other organisations but is normally considered a sole CLGE meeting open for guests according to invitations.

A press announcement shall be normally considered released after each meeting.

In every election period

A two-day seminar is arranged in every election period – first time autumn 2005. The seminar must be based on a research grant to the key speakers and the subject must be defined not less than 1½ year in advance. It is the purpose to raise and develop important questions in a manner that can be reported in a series of CLGE reports.

The Delft report from 1998 can be used as an example.

In seminar can be open to invited guests from adjacent organisations and the seminar can be arranged in cooperation with other organisations.

The seminar must be reported in press releases, articles in magazines and in a report which is printed and delivered to the members and to other relevant receivers.

CLGE Participation in Meetings and Congresses

It is of vital interest of CLGE to be represented in the European surveyors world as well as in the neighbouring world. It is as well important that the CLGE participation is recognized.

A list of the meetings and congresses which participation of CLGE is to be announced and to be maintained on the website. If the CLGE representative is known it shall be announced. The list shall contain incoming events as well to give the members an opportunity to seek information and to coordinate about participation or input of views.

A list of meetings in which CLGE or its members are regularly participating is put on the website.

A short report will be presented about every meeting giving the members the opportunity to

ask questions and to read the papers from the meeting. The reports will be presented on the website in due time.

The members are encouraged to wave the CLGE flag and will upon request be provided with necessary introduction letters and papers.

If the expenses are not covered by national organisations it is possible to apply for a grant to join the specific meeting. Such applications must be put to the Executive Board for decision well in advance.

Working parties and reports

The existing ALLEN report is to be updated online by the members in a new form introducing the use of the web-based procedures. The CLGE website will be adjusted during 2004-2005.

The Delft report on mutual recognition has been reprinted and will be distributed according to demands.

The Market report has been distributed in 2003 and copies are still available.

Working parties will be established only on the basis of a preliminary recommendation from a WP preparation group giving light to the necessary man-power needed and to the financial recourses and setting up a timetable. The WP can have members amongst the CLGE delegates but the weight will be put on a definite output in due time.

EU

EU matters are of special interest to CLGE and the CLGE Vice-President on this issue will establish contacts to the relevant offices in EU. Contacts to the incoming EU-members will be made in spring 2004 and invitations to join CLGE will be forwarded. Invitations to the General Assembly will be given and the fees (100 €) for one or two delegate will be paid by CLGE on request.

During this working period CLGE will establish a regularly set of meeting with EU offices to be able to report on topics of special interest to the European surveyors.

The Directives according to the Bologna Agreement and of the conditions of free movement of the labour force inside EU are of immediate interest for CLGE and its members. CLGE will provide a list of relevant reports, directives e.t.c on the CLGE website.

CEPLIS

CLGE will examine the results from the membership in CEPLIS and will put forward a report in the next General Assembly in Berlin.

Geometer Europas

The relations to GE are close and will be kept that way. The internal relations will be examined in order to discuss the best way of representing the European surveyors be it in a bilateral form like now or by a merged form.
