### **Profit and Loss Account**

#### Income

- The annual contribution paid by members more or less conforms with the budget, with a difference of 500€ due to the delay provided to two incoming members
- I have pleasure in announcing, and I hope that it will remain the case, that all the members have paid their contributions. Thank you to you all.
- We have made an agreement with GE concerning the Website and we have received a contribution of 11'500€ Expenses
- The expenses show a difference of 14'000€ from the budget, due to
  - Half of our contribution to the Strasbourg seminar, a sum of 10'000€, was already paid last year
  - Our contribution to CTF-EU and Public relations was 9'000€ less
  - Our contribution to CLGE enlargement was 4'500 € less
  - + The cost of the website was 9'500€ higher

### **Balance sheet**

Due to the profit of 7'309.95€, our capital has increased to 66'668.70€.

### **CS Money Market Fund Units**

 There was no activity during the year. The annual interest rate was 2.73% which amounts to 1'106.00€.
