In 1968, a legal cadastre (the so called “Grenzkataster”) was implemented in Austria with the objective to extend the purpose of the cadastre from taxation to legal validity of the property boundaries.

Now, 50 years later, we can evaluate the process of implementing the legal cadastre.

The joint PCC/Eurogeographics Conference in Vienna on 20 – 21 November 2018 did provide an overview of the situation in several European countries, how the cadastre is used, what quality aspects are set. What challenges are foreseen and what measures are taken to bring the cadastre in an appropriate quality to fulfill its role.
