



PARTNERSHIP CONVENTION OR MEMORANDUM OF UNDERSTANDING

Between :

SERBIAN UNION OF SURVEYORS (ORIG. SAVEZ GEODETA SRBIJE), Belgrade, Kneza Milosa 7a, represented by Mladen Šoškić

And :

ASSOCIATION OF GEODETIC ORGANIZATIONS OF SERBIA (ORIG. UDRUZENJE GEODETSKIH ORGANIZACIJA SRBIJE), Belgrade, Koste Glavinića 2, represented by president Vasilije Đurić

The signatories remind that

for years, diverse initiatives have been taken to get a Serbian member within the Council of European Geodetic Surveyors. For two years (2013 and 2014), there was a tentative from RGZ to be Principal CLGE member, but the membership has been downgraded to observing member again.

Currently RGZ is applying for the more appropriate Institutional Membership.

This creates the idea conditions to reconsider a Principal Membership for the Serbian Surveying associations.

THE AGREE ON THE FOLLOWING :

ARTICLE 1 – PURPOSE OF THE CONVENTION

The purpose of this agreement between the parties is to organise representation and the carrying of voting rights at the CLGE General Meeting. It also settles the payment of the annual membership fee.

ARTICLE 2 – REPRESENTATION

In accordance with the provisions of articles 5 and 11 of the CLGE Statutes, each national liaison group is entitled to 2 delegate seats at the CLGE General Assembly.

It has been agreed between the parties, in accordance with the provisions of article 11 of the CLGE Statutes authorising national liaison groups to appoint their own delegates, that from 19.4.2024., one seat will revert to the Serbian Union of Surveyors as head of delegation and the other seat to the Association Of Geodetic Organizations Of Serbia.

ARTICLE 3 – VOTES

The CLGE General Meeting grants a single voting right to associations from the same member country (art. 11 CLGE Statutes).

It has been agreed between the parties that the voting rights allocated to Serbian associations will be held by the head of delegation, i.e. the representative of the Serbian Union of Surveyors, unless the Association Of Geodetic Organizations Of Serbia is given express and specific proxy. Before the voting the head of delegation is obligated to conduct consultations with the other member of the delegation about the possible outcome of voting.

ARTICLE 4 – FEES

It is agreed that the Serbian Union of Surveyors will pay 50% of the annual fee and the Association Of Geodetic Organizations Of Serbia will be 50% of the annual fee.
